Important Notes:

In light of the COVID-19 situation and pursuant to the relevant order under the <u>COVID-19 (Temporary Measures)</u> Act 2020, the following arrangements will be adopted for the Annual General Meeting ("AGM"):

(1) Attendance at the virtual AGM

- a. An authorised representative will not be able to attend the AGM in person. An authorised representative may only attend the AGM by observing and listening to the proceedings of the meeting via Zoom. Only the authorised representatives on the latest authorised representative name list will be allowed to attend the AGM.
- b. Pre-registration for the virtual AGM is required. Authorised representatives must submit the pre-registration form (see **Annex A**) via email to <u>cue@cuesports.org.sg</u> by <u>23 June 2022</u> (Thursday) 5pm.
- c. Further Zoom login instructions can be found at **Annex B**.

(2) **Submission of Questions**

- a. All authorised representatives will not be able to submit questions live at the AGM. Instead, an authorised representative may submit questions in advance to Cuesports Singapore via email to cue@cuesports.org.sg, by 17 June 2022 (Friday) 5pm.
- b. Only substantial and relevant questions sent by <u>17 June 2022 (Friday) 5pm</u> will be addressed by the Board prior to or at the AGM. Whether a question is substantial and relevant would be determined by the solicitors engaged by the Board. Questions which concern a matter that will be put to a vote will be addressed by the Board by <u>18 June 2022 (Saturday) 6pm</u>, at Cuesports Singapore's official website (http://cuesports.org.sg) and its official Facebook page (https://www.facebook.com/CuesportsSingapore) and via email to the respective member club's email address.

(3) Voting by Proxy and Submission of Proxy Forms

a. All authorised representatives may only vote by proxy at the AGM. There will be no live voting at the AGM. Each authorised representative shall appoint the Chairman of the meeting, Mr. Justin Lee, President of Cuesports Singapore, as his/her proxy to attend, speak and vote at the meeting through a Proxy Form. All authorised representatives shall deposit the signed Proxy Form in PDF form by email to cue@cuesports.org.sg AND seechei@audittrust.com.sg, who are the independent auditors for this AGM, by 24 June 2022 (Friday) 5pm. All authorised representatives may submit their Proxy Forms directly to Cuesports Singapore, or through their respective clubs.




