Important Notes:

- 1. In view of the current COVID-19 situation in Singapore, all authorised representatives will not be allowed to attend the AGM in person.
- 2. All authorised representatives must appoint the Chairman of the Meeting as his/her proxy to attend, speak and vote on his/her behalf if such authorised representative wishes to exercise his/her voting rights at the AGM.
- This Proxy Form may be accessed at Cuesports Singapore's official website (http://cuesports.org.sg) and its official Facebook page (https://www.facebook.com/CuesportsSingapore). The Proxy Form shall also be sent to the member club's respective email address by 19 June 2022 (Sunday), 6pm.
- 4. Where an authorised representative who is entitled to vote appoints the Chairman of the Meeting as his/her proxy, he/she must give specific instructions as to voting, or abstentions from voting, in respect of a resolution in the form of proxy, failing which the appointment of the Chairman of the Meeting as proxy for that resolution will be treated as invalid. The authorised representative entitled to vote should indicate with a tick and/or cross in the relevant column i.e. "For", "Against" or "Abstain" in respect of the resolution. Where there is no tick and/or cross or no ascertainable indication of the representative's intention in respect of the resolution concerned, the vote would be treated as an abstention in respect of the relevant resolution concerned.
- 5. The signed proxy form in PDF form must be sent to Cuesports Singapore via email to <u>cue@cuesports.org.sg</u> AND <u>seechei@audittrust.com.sg</u>, who are the independent auditors for this AGM, by **24 June 2022 (Friday) 5pm**.
- 6. Once the Proxy Form is submitted, the votes in the Proxy Form are final and no changes to the votes are allowed.
- 7. Cuesports Singapore shall be entitled to reject the Proxy Form if it is incomplete, improperly completed or illegible or where the true intentions of the appointer are not ascertainable from the instructions of the appointer specified in the Proxy Form and/or make any appropriate enquiries before exercising its right to reject the Proxy Form.
- 8. The Proxy Form must be signed or electronically signed by the individual authorised representative.
