**1 NAME**

- 1.1 The governing body for Billiards, Snooker and Pool shall be called Cuesports Singapore, hereafter referred to as "Cuesports".

**2 DEFINITIONS**

- 2.1 In this Constitution words importing the singular include the plural and vice versa, and words importing any gender include the other genders.

- 2.2 In this Constitution unless the context requires otherwise:

- 2.2.1 "Advisor" means an advisor to Cuesports appointed in accordance with Article 33.
- 2.2.2 "Affiliate Member" means a Full Member and Associate Member admitted to Cuesports in accordance with Articles 9 and 10 respectively.
- 2.2.3 "AGM" means the Annual General Meeting of Cuesports members required to be held by Cuesports in each calendar year.
- 2.2.4 "Authorised Representative" means a person appointed by an Associate Member to attend a General Meeting of Cuesports.
- 2.2.5 "Authorised Voting Representative" means a person appointed by a Full Member to attend a General Meeting of Cuesports and to speak and vote on its behalf at such meetings.
- 2.2.6 "Associate Member" means an entity admitted as a Member of Cuesports in accordance with Article 10.
- 2.2.7 "Board" means the body consisting of Elected and Appointed Board Members that governs Cuesports.
- 2.2.8 "Board Committee" means a committee established under Article 31.
- 2.2.9 "Board Member" means a member of the Cuesports Board.
- 2.2.10 "Board Members" means all or some of the Board Members of Cuesports acting as a board.
- 2.2.11 "Billiards, Snooker and Pool" means the sport of Billiards, Snooker and Pool, including all the disciplines.
- 2.2.12 "Billiards, Snooker and Pool Events" means competitions, championships, demonstrations, exhibitions and any other events relating to Billiards, Snooker and Pool.
- 2.2.13 "By-law" means a by-law made under Article 36.
- 2.2.14 "CEO" means a person appointed as Chief Executive Officer or their equivalent by the Board according to the powers conferred on them by Article 34.
- 2.2.15 "Constitution" means this constitution as amended from time to time, and a reference to an article is a reference to an article of this Constitution.
- 2.2.16 "Delegate" means a person who is selected to stand for elections to the Board.

- 2.2.17 “Discipline” means a Billiards, Snooker and Pool sport programme defined by Singapore National Olympic Council (hereinafter referred to as “SNOC”) or the International Paralympics Committee and accepted by Cuesports as a program under its jurisdiction.
- 2.2.18 “EGM” means an Extraordinary General Meeting of Cuesports members called in accordance with Article 16.
- 2.2.19 “Family Members” means a person’s child, sibling, parent, spouse, spouse’s parent, spouse’s sibling, grandparent, or grandchildren.
- 2.2.20 “Full Member” means an entity admitted as a Member of Cuesports in accordance with Article 9.
- 2.2.21 “General Meeting” means a general meeting of Cuesports Members and includes the AGM and EGM.
- 2.2.22 “IHLs” means Institutions of Higher Learning such as Institutes of Technical Education, Polytechnics and Universities that are under the purview of the Ministry of Education of Singapore.
- 2.2.23 “Individual Member” means a person admitted as a Member of Cuesports in accordance with Article 11.
- 2.2.24 “Key Office Bearer” means a person who holds the position of President, Vice President, Honorary Secretary, Assistant Honorary Secretary, Honorary Treasurer, Assistant Treasurer or any other key appointment in the Cuesports Board.
- 2.2.25 “Member” means a member of Cuesports in accordance with Article 8.
- 2.2.26 “Objects” means the objects of Cuesports set out in Article 7.
- 2.2.27 “Patron” means a patron of Cuesports appointed in accordance with Article 33.
- 2.2.28 “Policy” means a policy made under Article 36.
- 2.2.29 “Special Resolution” means a resolution that must be passed by two-thirds of the members present at a General Meeting who are entitled to vote in accordance with this Constitution.
- 2.2.30 “Trustee” means a Trustee of Cuesports appointed in accordance with Article 42.

### **3 PLACE OF BUSINESS**

- 3.1 The place of business of Cuesports shall be at Stadium Drive #01-33 Sports Hub Singapore 397630 or such other place as may from time to time be decided by the Board, subject to the approval of the Registrar of Societies. Cuesports shall carry out its activities only in places and premises which have the prior written approval from the relevant authorities, where necessary.

### **4 AFFILIATION**

- 4.1 Cuesports shall be affiliated to Asian Confederation of Billiard Sports, the SNOC, and such other recognised bodies as the Board may deem necessary.

**5 AUTHORITY**

- 5.1 Cuesports shall strive for government and public recognition as the national governing body and authority for the sport of Billiards, Snooker and Pool in Singapore by virtue of Cuesports' affiliation to Asian Confederation of Billiard Sports and SNOC, and through endeavours that further the Objects of Cuesports.

**6 INCLUSIVITY**

- 6.1 Cuesports shall be inclusive and shall integrate into Cuesports' activities any adaptive form of Billiards, Snooker and Pool for people with disabilities that has been approved by Asian Confederation of Billiard Sports or the International Paralympics Committee.

**7 OBJECTS**

- 7.1 The objects of Cuesports shall be as follows:

- 7.1.1 Promote, develop and increase participation for the sport of Billiards, Snooker and Pool in Singapore.
- 7.1.2 Promote physical activity for health and wellness, foster community engagement and bonding for social inclusiveness and integration, and inspire the Singapore Spirit through Billiards, Snooker and Pool.
- 7.1.3 To engage communities and provide Billiards, Snooker and Pool access to vulnerable segments of the community such as youth at risk and the less privileged.
- 7.1.4 Unify, co-ordinate, sanction and organise Billiards, Snooker and Pool activities in Singapore, including national and international Billiards, Snooker and Pool tournaments and events.
- 7.1.5 Raise the competitive standards of Billiards, Snooker and Pool athletes in Singapore for sustainable elite level performance at international competitions and multi-sport major games.
- 7.1.6 Provide sport pathways and opportunities for the progression and advancement of Billiards, Snooker and Pool athletes, coaches and technical officials in Singapore.
- 7.1.7 Raise the technical capability of Billiards, Snooker and Pool coaches and technical officials in Singapore.
- 7.1.8 Do all things complementary or incidental to attain the aforesaid objects in Articles 7.1.1 to 7.1.7.

**8 MEMBERSHIP**

- 8.1 Cuesports' membership shall consist of 4 categories: Full Members, Associate Members, who will collectively be referred to as Cuesports' Affiliates, and Individual Members and Junior Members.
- 8.2 The list of the approved and most current Cuesports members shall be posted on Cuesports' official website.

**9 FULL MEMBERS**

- 9.1 Full Members shall be *bona fide* Clubs and Associations registered with the Registrar of Societies (ROS), including Government Agencies and Statutory Boards, interested in promoting the games of Billiards, Snooker and Pool, and willing to observe the rules and regulations of Cuesports.
- 9.2 Each Club/Association with a ROS registered number is entitled to only one membership, irrespective of its number of branches or locations in Singapore.
- 9.3 All Full Members must meet a minimum membership of 100 members at any given time in their register save that the minimum number of members must not also be concurrent members of another Full Member.
- 9.3 Full Members shall be involved in the promotion, training and/or development of Billiards, Snooker and Pool in Singapore.
- 9.5 As at time of admission, at least half of the Board of Full Members shall be Singapore citizens or half of the members are Singapore citizens. Clubs and Associations intending to apply to be Full Members should also provide a list of their members, shareholders and/or management and their nationalities alongside their membership applications.
- 9.6 Full Members shall have full voting rights at Cuesports' General Meetings.
- 9.7 Full Members shall be approved by a special resolution at an AGM, and may only exercise their voting rights at subsequent General Meetings.
- 9.8 Full Members may only be removed as a member of Cuesports by a special resolution at an AGM unless for the reason stated in Article 14.3.

**10 ASSOCIATE MEMBERS**

- 10.1 Associate Membership is open to bona fide business entities registered with Accounting and Corporate Regulatory Authority (ACRA) and who are interested in promoting the games of Billiards, Snooker and Pool, who are willing to observe the rules and regulations of Cuesports but are not eligible for Full Membership. Associate Members shall not be entitled to vote at Cuesports' General Meetings or be elected to the Board.
- 10.2 Associate Members may authorise up to 5 of its members to receive complimentary membership to Cuesports' Clubhouse. The 5 authorised members will be accorded the rights and privileges similar to that of Individual Members of Cuesports and thus, shall not have the right to vote at Cuesports' General Meetings or be elected to the Board.
- 10.3 All Associate Membership shall be approved by the Board.

**11 INDIVIDUAL MEMBERS**

- 11.1 Individual Membership is open to residents in Singapore above the age of 18 and is willing to observe the rules and regulations of Cuesports. Individual Members shall not be entitled to vote at Cuesports' General Meetings or be elected to the Board .
- 11.2 All Individual Memberships shall be approved by the Board or by the Honorary Secretary or CEO if delegated by the Board.

**12 JUNIOR MEMBERS**

- 12.1 Junior Membership is open to residents in Singapore above the age of 12 and below the age of 18 and is willing to observe the rules and regulations of Cuesports. Applicants who are below eighteen (18) years of age must have the written consent of their parent or guardian.
- 12.2 Junior Members shall not be entitled to vote at Cuesports' General Meetings or be elected to the Board and shall have restricted privileges and facilities in Cuesports as specified in the Bye-Laws.
- 12.3 All Junior Memberships shall be approved by the Board or by the Honorary Secretary or CEO if delegated by the Board.

**13 APPLICATION FOR MEMBERSHIP**

- 13.1 All membership applications shall be submitted to the Honorary Secretary as prescribed by Cuesports. The applications must be signed by the applicant.
- 13.2 Application for membership may be rejected on any of the following grounds:
  - 13.2.1 The applicant does not satisfy all the relevant membership criteria set out in the relevant membership category in this Constitution;
  - 13.2.2 The applicant has been convicted of an offence involving moral turpitude, declared a bankrupt, wound up or dissolved.
  - 13.2.3 Where accepting the applicant would in the Board's absolute discretion be deemed prejudicial to the interest of Cuesports as a whole.
- 13.3 A member may resign his membership by giving 30 days written notice to the Honorary Secretary; neither the entrance fee nor the annual subscription shall be refunded in this respect.

**14 MEMBERSHIP FEES**

- 14.1 Members shall pay a one-time membership entrance fee and an annual membership renewal fee as determined by the Board from time to time. Membership renewal fees shall be paid by 1<sup>st</sup> June of each year.
- 14.2 The Board may suspend members who have membership renewal fee arrears of one (1) month or more. Suspended members shall not be entitled to any of the rights and privileges of membership including voting rights at General Meetings.
- 14.3 The Board shall terminate members who have membership renewal fee arrears of more than one (1) year. Terminated members may only apply to be reinstated as a member after a lapse of one (1) year.
- 14.4 The list of suspended and terminated Affiliate Members shall be posted on Cuesports' official website along with the effective date of their suspension or termination.
- 14.5 The income and property of Cuesports whensoever derived shall be applied towards the promotion of the objects of Cuesports as set forth in this Constitution and no portion thereof shall be paid or transferred directly or indirectly by way of dividend or bonus or otherwise howsoever by way of profit to the persons who at any time are or have been members of Cuesports or to any of them or to any person claiming through any of them.

**15 ANNUAL GENERAL MEETINGS**

- 15.1 The supreme authority of Cuesports is vested in a General Meeting of the members. The Annual General Meeting (AGM) shall be held on a Saturday in June, which shall be not later than 30<sup>th</sup> June.
- 15.2 If there are any unavoidable reasons for delay in holding the AGM by 30<sup>th</sup> June, the members shall be notified of the reason by 30<sup>th</sup> May through email or on Cuesports' official website. The AGM may be postponed to a later date if no more than one-third (1/3) of the Full Members raise any objections in writing to Cuesports within seven (7) days from the date of this notification.
- 15.3 At least twenty-one (21) days' notice shall be provided to Affiliate Members, through email and Cuesports' official website, specifying the place, date and time of the AGM.
- 15.4 Full Members who wish to table a resolution for the General Meeting's approval must notify the Honorary Secretary in writing at least fourteen (14) days before the date of the AGM.
- 15.5 The agenda for the AGM, the Board's annual report and the audited financial statements for the preceding financial year, shall be forwarded to the members at least seven (7) days before the date of the AGM.
- 15.6 The business to be transacted at the AGM shall be:
- 15.6.1 To approve the annual report and the previous financial year's audited financial statements.
  - 15.6.2 To approve any resolutions tabled by Full Members in accordance with Article 15.4 or by the Board.
  - 15.6.3 Where applicable, to appoint auditors for the ensuing term.
  - 15.6.4 Where applicable, to approve or remove Full Members.
  - 15.6.5 Where applicable, to approve the list of nominations received and to hold the election for Board Members.
- 15.7 No business other than that stated in the notice and agenda for the AGM shall be transacted at the General Meeting.
- 15.8 General Meetings may be conducted, wholly or partly, by electronic means. Members must at least be allowed to contemporaneously observe the proceedings of such meetings by audio and video means (e.g. "live" webcast) and to cast their vote electronically where required. Details on the arrangements for meetings to be conducted by electronic means shall be provided to members in the notice of the meeting.

**16 EXTRAORDINARY GENERAL MEETINGS**

- 16.1 An Extraordinary General Meeting (EGM) may be convened at any time by order of the Board or on receipt of a written requisition by at least one-third (1/3) of the Full Members on Cuesports' membership register. Such requisition shall state the business that is to be transacted at the requested EGM.
- 16.2 The Board shall convene the EGM within one (1) month of receiving the requisition. Full Members who requisitioned the EGM may proceed to convene the EGM if one is not convened by the Board and shall provide the relevant notice and agenda for the meeting to the Full Members.

- 16.3 At least fourteen (14) days' notice shall be provided to Affiliate Members, through email and Cuesports' official website, specifying the place, date and time of the EGM along with the resolutions to be passed at the meeting.

**17 ATTENDANCE FOR GENERAL MEETINGS**

- 17.1 All members of Cuesports shall be eligible to attend General Meetings.
- 17.2 The Board may also invite various others including Cuesports' auditors, legal advisers and observers from Cuesports' stakeholders for General Meetings. Such invitees shall not participate in the proceedings of the General Meetings and may only address the meeting if deemed necessary by the Chairman or with the consent of the authorised delegates present at the meeting.

**FULL MEMBERS:**

- 17.3 Each Full Member is entitled to have one (1) authorised voting representative who is above twenty-one (21) years of age to attend a General Meeting and to speak and vote on its behalf at such meetings. Authorisation from the Club or Association must be in writing.
- 17.4 The name of the authorised voting representative from each Full Member to be submitted by fax and/or post to reach Cuesports before 31<sup>st</sup> March of each year. No change is allowed after this date for the year.
- 17.5 In a case of non-submission, any prior list of voting representatives on Cuesports' records will be regarded as the current list. If there is non-submission of current or any prior list on record, it will be deemed that the Full Member has opted out for that current year.

**ASSOCIATE MEMBERS:**

- 17.6 Each Associate Member is entitled to have one (1) authorised representative to attend a General Meeting. The authorised representatives of Associate Members who will be attending the General Meeting shall be notified to the Honorary Secretary at least three (3) days before the date specified for the General Meeting.

**INDIVIDUAL MEMBERS:**

- 17.7 Individuals who will be attending the General Meeting shall be notified to the Honorary Secretary at least three (3) days before the date specified for the General Meeting.

**JUNIOR MEMBERS:**

- 17.8 Individuals who will be attending the General Meeting shall be notified to the Honorary Secretary at least three (3) days before the date specified for the General Meeting.

**18 QUORUM FOR GENERAL MEETINGS**

- 18.1 At least a quarter (1/4) of the voting members (i.e. Full Members), present at a General Meeting shall form a quorum.
- 18.2 In the event of there being no quorum at the commencement of a General Meeting, the meeting shall be adjourned for half-an-hour and should the number then present be insufficient to form a quorum, those present shall be considered a quorum, but they shall have no power to amend or make addition to the existing Constitution.

- 18.3 The President of Cuesports shall take the chair at all Board and General Meetings, and in the absence of the President, one of the Vice-Presidents shall take the chair. If at any meeting neither the President nor the Vice-Presidents shall be present within 15 minutes of the time appointed for holding the meeting, the members present shall choose a Chairman from among themselves.

**19 VOTING AT GENERAL MEETINGS**

- 19.1 Only authorised voting representatives of Full Members who are above the age of twenty-one (21) shall be eligible to vote at General Meetings and for the election of Board Members. However, only the authorised voting representatives (hereinafter referred to as "the delegate") may be elected to the Board.
- 19.2 Each authorised voting representative shall have one vote. Board Members shall have no voting rights at General Meetings unless he is an authorised voting representative of a Full Member.
- 19.3 Voting by proxy is not allowed at all General Meetings unless the same is authorised or permitted by prevailing laws and regulations.
- 19.4 All resolutions, with the exception of special resolutions, shall be approved by a simple majority of the votes cast. All special resolutions shall be approved by at least two-thirds (2/3) of the votes cast.
- 19.5 Electronic voting shall be allowed for general meetings conducted by electronic means. Electronic voting can be by a physical or digital show of hands or by an online poll.

**20 GOVERNING BOARD**

- 20.1 Cuesports shall be governed by a Board between Annual General Meetings. The Board shall have all the powers necessary to manage the affairs of Cuesports other than those matters reserved for the Annual General Meeting's approval.
- 20.2 The Board shall consist of the following Board Members, who will be elected at the Annual General Meeting once every two years:
- (a) A President
  - (b) Three (3) Vice Presidents
  - (c) An Honorary Secretary
  - (d) An Honorary Treasurer
  - (e) Assistant Treasurer
  - (f) Two (2) Board Members

In addition, the Board shall also comprise an Athlete Commission Chairman and between three (3) to five (5) appointed Board Members.

- 20.3 More than half of the Board shall be comprised of Singapore citizens.

**21 NOMINATION AND ELECTION**

- 21.1 Only the representatives authorised by Full Members which are not in arrears for any payments to Cuesports may offer themselves for nomination as candidates for office. Each Full Member may nominate only one delegate from its list of authorised voting representatives as per Article 19.1.

- 21.2 All nominations for the Board election shall be submitted in writing via prescribed forms and along with the required supporting documents as may be determined by the Board and must reach the Cuesports office at least seven (7) days before the AGM, and any nominations received thereafter shall be invalid.
- 21.3 All nominations must be proposed by the Full Member of the delegate and seconded by or on behalf of another Full Member.
- 21.4 Nomination forms shall include a declaration by the nominee of any personal or business interest that may put the nominee in a conflict of interest in relation to Cuesports or its members. No more than three (3) nominees for any Board election may be family members and such relationships must be declared upfront in the nomination and before the Board election.
- 21.5 Nominated candidates must fulfil all the eligibility conditions in the articles of Article 23 (Board Members) and Article 24 (Elected Board Members) .
- 21.6 The voting eligibility of Full Members, their authorized delegates and the nominated candidates for the Board election shall be verified and confirmed by a panel comprising two (2) or more independent members from the Board or in the absence or unavailability of the same, an auditor or legal professional appointed by the Board.
- 21.7 The list of eligible nominees shall be published in Cuesports' official website and emailed to all Members at least five (5) days before the AGM where the election is to be held.
- 21.8 The election shall be conducted or supervised by an independent member of the Board or an auditor or legal professional appointed by the Board
- 21.9 Election will be by secret ballot and the result shall be based on a simple majority of the votes cast.
- 21.10 Any tie in votes that affects the outcome of the election shall be resolved through a subsequent round(s) of voting. If the tie involves more than two (2) candidates, the candidate with the lowest number of votes shall be eliminated after each round.
- 21.11 If a tie persists after two (2) successive rounds of voting involving the same candidates, the Chairman who is presiding over the election shall decide to either exercise a casting vote, where the Chairman had been so empowered by the members, or draw lots to resolve the tie.
- 21.12 In any event, the Chairman shall not exercise the casting vote option if he has any conflict of interest in the choice of candidate.
- 21.13 The counting of the votes shall be overseen and verified by two (2) or more scrutineers from the members present at the AGM who are not contesting the election and/or the representatives from Cuesports' auditors and/or legal advisers who are present at the AGM.

## **22 KEY OFFICE BEARERS**

- 22.1 The Board shall elect from among themselves key office bearers, who will minimally be the President, Vice President, Honorary Secretary, Treasurer and Assistant Treasurer following an AGM where an election is held or whenever a vacancy arises.
- 22.2 The President, Vice President(s) and Honorary Secretary shall be Elected Board Members who are Singapore citizens, and shall be elected by the Elected Board Members.

22.3 The Treasurer should preferably have a recognized accounting qualification and / or appropriate practical experience.

22.4 The President should have served and made positive contributions to Cuesports as an ex-athlete, official or elected Board member, or should be a prominent individual of good standing within the sport and / or community.

**23 BOARD MEMBERS**

23.1 Board members shall at least be twenty-one (21) years of age and shall be Singapore citizens or Permanent Residents.

23.2 Board members shall not be individuals who are disqualified from serving on the Board of charities or companies pursuant to the Charities Act and Companies Act or have past convictions for offences for which criminal record cannot be spent pursuant to the Registration of Criminals Act 1949 (Third Schedule).

23.3 Board members shall not be serving a suspension or ban from SNOG or other regulatory authority.

23.4 Board members shall be persons of good character with the relevant experience and credentials.

23.5 Board members shall neither be a paid employee of Cuesports nor have a family member who is a paid employee of Cuesports.

23.6 No more than three (3) of the Board members shall be family members.

23.7 Any change of Board members shall be notified to the Registrar of Societies and the Commissioner of Charities within two (2) weeks of the change.

**24 ELECTED BOARD MEMBERS**

24.1 An Elected Board Member shall be an authorised delegate or representative of an Affiliate Member of Cuesports who is duly elected by the voting members at an AGM.

24.2 Elected Board Members shall act in the best interest of Cuesports and not do anything to bring the Cuesports into disrepute.

24.3 The Board may at any time appoint a suitable person to fill a position vacated by an Elected Board Member for the remaining term of office for the vacated position.

24.4 Where more than half of the Elected Board Member positions become vacant, the Board shall convene a General Meeting (EGM or AGM), within two months from the positions becoming vacant, in order to elect the replacements for the remaining period of office.

**25 APPOINTED BOARD MEMBERS**

25.1 The Elected Board Members will appoint between three (3) to five (5) other Board members to ensure an appropriate balance and diversity of skills, experience, ethnicity, and gender within the Board.

25.2 Appointed Board Members shall preferably be from the legal, accounting or medical profession or shall be experts in other relevant fields including marketing, event management or coach education.

- 25.3 The majority of the Appointed Board Members shall be independent members who do not have any association with the Affiliates, including as members or otherwise, and who do not have any vested interest in the affairs or business of Cuesports Singapore.
- 25.4 The Board may at any time appoint a suitable person to fill a position vacated by an Appointed Board Member for the remaining term of office for the vacated position.
- 25.5 The Board shall have the power to remove an Appointed Board member before the expiration of his term of office and may appoint another person in his stead for the remaining term of his office.

## **26 BOARD TENURE**

- 26.1 The term of office for all Board Members elected at the Annual General Meeting and Appointed Board Members shall be two years.
- 26.2 Counting from 2021, Board members may serve a maximum tenure of eight (8) consecutive years on the Board and upon reaching this tenure limit, shall only be eligible for re-election or re-appointment to the Board after a lapse of at least two (2) years.
- 26.3 A Board Member may only hold the appointment of Treasurer for a maximum of four (4) consecutive years and may only be considered for re-appointment as a Treasurer after a lapse of at least two (2) years.
- 26.4 A retiring President who does not defend his post for the ensuing term of office shall serve in the Board as the Immediate Past President for one electoral term and shall not be eligible to vote on any matters at Board Meetings.

## **27 BOARD ROLE AND POWERS**

- 27.1 The role and powers of the Board shall be as follows:
  - 27.1.1 Provide stewardship and trusteeship on behalf of members and be responsible for ensuring that Cuesports remains viable and effective in the present and for the future.
  - 27.1.2 Provide strategic leadership, set objectives, and ensure that the necessary plans, policies, programs and resources are in place for Cuesports to meet its objectives.
  - 27.1.3 Ensure all legal and statutory obligations are met and all constitutional and governance requirements are complied with.
  - 27.1.4 Establish a framework of prudent and effective controls which enables risk to be assessed and managed, including safeguarding of Cuesports's assets and the public funds it receives.
  - 27.1.5 Set Cuesports' values and standards and ensure that obligations to members and other stakeholders are understood and met, and address all disciplinary issues that arise.
  - 27.1.6 Be responsible for the appointment of the CEO and other senior management employees of Cuesports and provide them with clear documented roles, responsibilities and accountabilities.
  - 27.1.7 Review management and Board performance periodically.

- 27.1.8 Manage conflict of interest and take appropriate measures to ensure that Cuesports is protected against any personal or business interests of Board members and employees of Cuesports.
- 27.1.9 Identify and sufficiently engage the key stakeholder groups of Cuesports and seek their views and feedback on Cuesports' strategies and policies.
- 27.1.10 Consider financial sustainability, social issues and environmental factors as part of its strategy and policy formulation
- 27.1.11 Raise funds for Cuesports and approve any expenditure from the funds and/or reserves of Cuesports for Cuesports' activities, subject to Clause 27.1.12.
- 27.1.12 Decisions that involve the acquisition and disposal of immovable properties / assets, and expenditures of significant value that draws on Cuesports' financial reserves (i.e. more than 10% of reserves or \$0.25M whichever is higher) should be approved at a General Meeting by a resolution.

## **28 DUTIES OF OFFICE BEARERS**

- 28.1 The President shall chair all General and Board meetings. The President shall also represent Cuesports in all matters with outside persons.
- 28.2 The three (3) Vice-Presidents shall assist the President and one of the three (3) Vice-Presidents designated by the Board shall deputise the President in his absence. He shall also serve as Chairman of at least one Committee.
- 28.3 The Honorary Secretary shall ensure that all records of Cuesports, except financial, are kept safely and shall be responsible for their correctness. He shall ensure that the minutes of all General and Board meetings are recorded correctly. He shall also ensure that an up-to-date Register of Members is maintained at all times.
- 28.4 The Treasurer shall:
  - 28.4.1 Be responsible for the funds of Cuesports;
  - 28.4.2 Keep an account of all monetary transactions and shall be responsible for their correctness;
  - 28.4.3 Report on the financial status of Cuesports at Board meetings and present audited financial reports at AGMs; and
  - 28.4.4 Not hold office in the Audit Committee.
- 28.5 The Assistant Treasurer shall assist the Treasurer and shall deputise for the Treasurer in his absence, and shall not hold office in the Audit Committee.
- 28.6 All cheques, electronic or online payments for withdrawals from the bank shall be co-signed by the Treasurer or Assistant Treasurer, and either the President or one of the Vice Presidents.
- 28.7 All other Board Members shall assist in the management of Cuesports and perform duties assigned by the Board from time to time.

29 **BOARD MEETINGS**

- 29.1 A Board Meeting shall be held at least once every two (2) months or such durations as may be determined by the Board after giving at least seven (7) days' notice to Board Members.
- 29.2 A Board Member who is absent for three (3) consecutive Board meetings without any reasonable excuse accepted by the Board shall be deemed to have withdrawn from the Board.
- 29.3 At least half of the Board members must be present to form a quorum and for the meeting proceedings to be valid. This will include Board members who participate in the meeting via telephone or video conferencing.
- 29.4 Voting at Board meetings shall be by show of hands unless the meeting decides otherwise by a majority vote for a secret ballot. All Elected Board Members and Appointed Board Members who qualify as independent members shall have one (1) vote each at Board meetings.
- 29.5 Board Members who are not present at a meeting may write in prior to the meeting or call in during the meeting to vote on resolutions or required decisions circulated prior to the meeting.
- 29.6 The Chairman of the Board meeting shall have a casting vote (i.e. second vote) in the event of a tie in the votes.

30 **CIRCULAR RESOLUTIONS**

- 30.1 The Board may by a circular resolution decide on any matters of Cuesports as stated within its powers under this Constitution. Such circular resolutions shall be as effective as a resolution passed at a Board meeting duly convened and held.
- 30.2 The Honorary Secretary or CEO shall circulate such resolutions for the Board Members' approval upon the request by any of the Board Member who shall have a seconder for the same.
- 30.3 The circulation of such resolution(s) shall be relayed to Board Members by any acceptable means of communication adopted by the Board, including via email.
- 30.4 A circular resolution shall be carried upon acceptance by a simple majority of members from the Board and shall be tabled and ratified at the following Board meeting.

31 **BOARD COMMITTEES**

- 31.1 The Board may appoint Board Committees comprised of Cuesports members and/or independent experts to assist the Board in the management and administration of Cuesports.
- 31.2 The Board may delegate to such Board Committees such powers as it deems necessary.
- 31.3 The Board shall minimally appoint the following Board Committees with the appropriate terms of reference:
  - 31.3.1 Audit Committee
  - 31.3.2 Selections Committee
  - 31.3.3 Appeals Committee
  - 31.3.4 Disciplinary Committee

- 31.4 The Audit Committee, Selections Committee, Appeals Committee and Disciplinary Committee shall comprise of at least three (3) persons appointed by the Board. Each of these four (4) Board Committees shall be headed a Board member and shall have no more than two-thirds (2/3) of its members from the Board.

32 **ATHLETES COMMISSION**

- 32.1 Cuesports shall establish an Athletes Commission (AC) with the view to providing a process to promote open communication with the athletes.
- 32.2 The AC shall comprise of no more than five (5) elected members, who are either past or present national Billiards, Snooker and Pool athletes, including the Chairman who must be a former National Billiards, Snooker, Pool athlete.
- 32.3 The Chairman and members of the AC shall be elected by National athletes who have represented Singapore in international Billiards, Snooker, Pool competitions within the past twenty-four (24) months.
- 32.4 The term of office of the AC members and their term limits, if any, shall follow that of the Board.
- 32.5 The Chairman of the AC shall be appointed as a Board member with voting rights and shall represent the AC in the Board until the expiry of his term as Chairman of the AC.

33 **ADVISORS AND PATRONS**

- 33.1 The Board may appoint Advisors and/or Patrons who may or may not be a Member of Cuesports to advise the Board in such matters as and when the Board deems necessary.
- 33.2 The Advisors and Patrons so appointed shall have no voting rights in the Board.
- 33.3 Patrons may be invited by the President and/or the Board to chair a General Meeting of Cuesports in which case the Patron shall have no voting rights.

34 **CHIEF EXECUTIVE OFFICER**

- 34.1 The Board may appoint a CEO or an equivalent to lead the Cuesports management and secretariat staff.
- 34.2 The CEO shall hold office on the terms and conditions (including as to remuneration) and with the powers, duties and authorities, determined by the Board.
- 34.3 The exercise of the CEO's powers and authorities, and the performance of the CEO's duties, shall always be subject to the control of the Board.
- 34.4 The role of the CEO will be to implement the strategies, plans and policies approved by the Board and to be responsible for the management and direction of Cuesports and its finances.
- 34.5 The CEO shall attend all Cuesports meetings including General Meetings and Board meetings, subject to a determination otherwise by the Board. The CEO shall not have a vote at these meetings but may speak on any matters where required.
- 34.6 Subject to the terms and conditions of the appointment, the Board may suspend or remove the CEO from that office.

**35     AUDIT AND FINANCIAL YEAR**

- 35.1     A firm of Public Accountants and Chartered Accountants shall be appointed as auditors at each AGM for the next financial year and shall be eligible for reappointment.
- 35.2     The auditor shall be changed at least once every 5 years, whether to another auditor from the same auditing firm or company or to another auditor from a different auditing firm or company.
- 35.3     The auditors may be required by the President to audit Cuesports' accounts for any period within their tenure of office at any date and make a report to the Board.
- 35.4     The auditors will be required to audit each financial year's accounts and present a report upon them to the AGM.
- 35.5     Cuesports' financial year shall be from 1<sup>st</sup> April of each year to 31<sup>st</sup> March the following year.

**36     POLICIES AND BY-LAWS**

- 36.1     The Board shall have the power to approve, create, alter or revoke by-laws, policies, regulations, procedures and practices in relation to the management and administration of Cuesports as it deems fit.
- 36.2     Such by-laws, policies, regulations, procedures and practices from time to time in force shall not be inconsistent with the provisions of this Constitution.
- 36.3     If there is inconsistency, the provisions of the Constitution shall prevail, and that by-law, policy, regulation, procedure or practice shall to the extent of the inconsistency be void.
- 36.4     When in force, such by-laws, policies, regulations, procedures and practices shall be binding on all Members and has the same effect as a provision in this Constitution.

**37     CONFLICT OF INTEREST**

- 37.1     Board members shall act in the best interests of Cuesports, and the Board shall set clear policies, procedures and take appropriate measures to declare, prevent and address any conflict of interest that may arise.
- 37.2     Whenever a member of the Board is in any way, directly or indirectly, has an interest in a transaction or project or other matter to be discussed at a meeting, the member shall disclose the nature of his interest before the discussion on the matter begins. The Board Member concerned shall then offer to withdraw and leave the meeting and not participate in the discussion or vote on the matter. The Board shall decide if this should be accepted.

**38     ANTI-DOPING**

- 38.1     Cuesports shall recognise the right of all its athletes to participate in clean sport and is committed to ensuring the sport is doping-free and is free of any manipulation of competitions.
- 38.2     All Affiliate Members, members, athletes, participants, staff and other individuals, who are subject to the jurisdiction of Cuesports are bound by and agree to abide by all World Anti-Doping Code-compliant anti-doping rules applicable to the sport and to comply with the Olympic Movement Code on the Prevention of Manipulation of Competitions.

**39 SAFE SPORT**

39.1 Cuesports shall be committed to ensuring the safety and wellbeing of Billiards, Snooker and Pool athletes and practitioners in Singapore and shall take all necessary measures to protect them from all forms of harassment and abuse.

39.2 All affiliates, members, athletes, participants, staff and other individuals, who are subject to the jurisdiction of Cuesports are bound by and agree to abide by the Safe Sport Unified Code and to comply with the applicable rules under the Safe Sport Programme.

**40 DISPUTE RESOLUTION**

40.1 Any dispute arising amongst Members or between any Member and Cuesports shall be resolved in accordance with the Framework for Alternative Dispute Resolution for Sports (ADR Sports) or other dispute resolution framework jointly administered for the time being by Sport Singapore, the Singapore Mediation Centre and the Singapore Institute of Arbitrators.

**41 PRESS RELEASE**

41.1 Only the President or his/her delegate shall be entitled to give press releases relating to matters concerning Cuesports.

**42 TRUSTEES**

42.1 If Cuesports at any time acquires any immovable property, such property shall be vested in trustees subject to a declaration of trust.

42.2 The trustees of Cuesports shall:

42.2.1 Not be more than four (4) and not less than two (2) in number.

42.2.2 Be elected by a General Meeting of members.

42.2.3 Not effect any sale or mortgage of property without the prior approval of the General Meeting of members.

42.3 The office of the trustee shall be vacated:

42.3.1 If the trustee dies or becomes of unsound mind.

42.3.2 If he is absent from the Republic of Singapore for a period of more than one (1) year.

42.3.3 If he is guilty of misconduct of such a kind as to render it undesirable that he continues as a trustee.

42.3.4 If he submits notice of resignation from his trusteeship.

42.4 Notice of any proposal to remove a trustee from his trusteeship or to appoint a new trustee to fill a vacancy must be given by posting it on Cuesports' notice board and / or on Cuesports' website at least two (2) weeks before the General Meeting at which the proposal is to be discussed. The result of such General Meeting shall then be notified to the Registrar of Societies and Commissioner of Charities.

42.5 The address of each immovable property, name of each trustee and any subsequent change must be notified to the Registrar of Societies and Commissioner of Charities.

**43 VISITORS AND GUESTS**

- 43.1 Visitors and guests may be admitted into the premises of Cuesports but they shall not be admitted into the privileges of Cuesports. All visitors and guests shall abide by Cuesports' rules and regulations.

**44 PROHIBITIONS**

- 44.1 Gambling of any kind, excluding the promotion or conduct of a private lottery which has been permitted under the Private Lotteries Act 2011, is forbidden on Cuesports' premises. The introduction of materials for gambling or drug taking and of bad characters into the premises is prohibited.
- 44.2 The funds of Cuesports shall not be used to pay the fines of members who have been convicted in court of law.
- 44.3 Cuesports shall not engage in any trade union activity as defined in any written law relating to trade unions for the time being in force in Singapore.
- 44.4 Cuesports shall not indulge in any political activity or allow its funds and/or premises to be used for political purposes.
- 44.5 Cuesports shall not hold any lottery, whether confined to members or not, in the name of Cuesports or of its office-bearers, Board or members unless with the prior approval of the relevant authorities.
- 44.6 Cuesports shall not raise funds from the public for whatever purposes without the prior approval in writing of the Assistant Director Operations, Licensing Division, Singapore Police Force and other relevant authorities, where necessary.

**45 CESSATION OF CHARITY STATUS**

- 45.1 In the event that Cuesports ceases to be a registered charity under the Charities Act 1994, all debts, liabilities legally incurred on behalf of Cuesports shall be fully discharged, and the remaining funds will be donated to charitable organization(s) or Institution(s) of a Public Character, when Cuesports is an institution of a Public Character, as the case may be, with similar objectives in Singapore which is (are) registered under the Charities Act 1994 as the members of Cuesports may determine at the General Meeting.

**46 DISSOLUTION**

- 46.1 Cuesports shall not be dissolved except with the consent of not less than three-fifths (3/5) of those entitled for the time being to vote at General Meetings.
- 46.2 In the event of Cuesports being dissolved as provided above, all debts and liabilities legally incurred on behalf of Cuesports shall be fully discharged, and the remaining funds will be donated to charitable organization(s), or Institution(s) of a Public Character, when Cuesports is an Institution of a Public Character, as the case may be, with similar objectives in Singapore which is (are) registered under the Charities Act, as the members of Cuesports may determine at the General Meeting.
- 46.3 A Certificate of Dissolution shall be given within seven (7) days of the dissolution to the Registrar of Societies and Commissioner of Charities.

47 **AMENDMENTS TO CONSTITUTION**

- 47.1 No alterations, amendments or additions/deletions to this Constitution shall be made except at a General Meeting and by a special resolution.
- 47.2 Such alterations, amendments or additions/deletions shall only take effect after the approval from the Registrar of Societies and the Commissioner of Charities has been received.
- 47.3 Any proposal to amend the Constitution shall be notified in writing to Cuesports at least fourteen (14) days before the General Meeting together with a copy of the proposed amendments.

48 **MATTERS NOT PROVIDED FOR**

- 48.1 In all matters not provided for in this Constitution or doubts on the proper interpretation of the Articles in this Constitution, the decision of the Board shall be final unless it is reversed at a General Meeting of members.
