



NATIONAL 10 BALL WOMEN CHAMPIONSHIP RULES & REGULATIONS

1. ENTRIES

- 1.1. The tournament is only open to Singapore Citizens and Permanent Residents of Singapore.
- 1.2. Participants must sign up by the closing of entry date. Any entry after the closing date will not be accepted.
- 1.3. Participants are to pay the entry fee upon submission of entry. If entry fee is not received by the draw date, the entry will not be accepted. Cuesports Singapore reserve the rights to not draw your name for the tournament.
- 1.4. For clubs, an undertaking letter (provided on the Tournament page in Cuesports Singapore Website) must be sent to Cuesports Singapore before the closing date.
- 1.5. Entry fees for tournaments will be as follows:

3. TOURNAMENT VENUE

- 3.1. The tournament will be played at **Aspire Recreation Centre located at 1 Maritime Square, #04-02, Singapore 099253.**

4. GAME RULES

- 4.1. The balls will be racked with the 1 ball placed on the foot spot, 2 and 3 ball placed on the corners.
- 4.2. Players are allowed to check the rack **twice** and make **one** request for re-rack or make adjustments to the rack when a 1-1 referee is deployed.
- 4.3. Re-breaking is not an option.
- 4.4. No pattern racking.
- 4.5. Obvious shots need not be called.
- 4.6. The 10 ball must be the last ball to be pocketed to win the rack.
- 4.7. After the breaking of the rack, should 2 or more balls remain on top of the magic rack, preventing it from being removed, at the discretion of the referee, the game may continue without having the magic rack removed.

5.3. WOMEN CATEGORY

Women	Format
Preliminary round - Last 16	Race to 5
Quarter Final - Semi Final	Race to 6
Grand Final	Race to 7

5.4. In the event that the number of entries falls below 80 for the open category or 20 for the women's category by the closing date, Cuesports Singapore reserves the right to cancel the affected category and refund the registration fees. Additionally, the prize money may be adjusted according to the number of entries in the affected category.

- Women Category - 32 slots maximum

6. TOURNAMENT SEEDING

6.1. Based on the National Pool Ranking List. Top 16 ranked players for Open and top 8 ranked players for Women will be seeded for the tournament.

6.2. Any ranked players that did not participate in the tournament, the subsequent ranked players will be pushed up accordingly.

6.3. Seeded players for the open category will play from the last 32 knockout stages where they will be joined by 16 group stage qualifiers.



7. DRESS CODE (Open & Women Category)

7.1. Preliminary Rounds - Quarter Final

- Event tee to be worn if any
 - i. If not, Polo T-shirt / collared shirt
- **Dark** dress pants
- **Dark** Covered shoes (Sneakers / Sports Shoes)

7.2. Semi Final & Grand Final

- Long sleeve plain formal shirt
- Vest and bow tie
- **Dark** dress pants
- **Dark** Covered shoes (Sneakers / Sports Shoes)

7.3. Players who are not properly attired will be issued a penalty of 1 rack immediately.

8. SCHEDULE

8.1. The schedule for the tournament is as follows:

8.2. Fixtures / results can be found on Cuesports Singapore's Facebook page (<https://www.facebook.com/CuesportsSingapore/>) and tournament venue after the date of publication of draw.

8.3. Players shall be solely responsible for monitoring their own fixtures and results. The Organizer reserves the right to make any necessary adjustments at its discretion.

8.4. In the event of a scheduling conflict between match times for the Open and Women's categories, the Organizer reserves the right to amend the match timing as deemed appropriate under the circumstances.

8.5. No delays or postponements of matches shall be permitted unless expressly authorized by the Organizer.



9. TOURNAMENT REPORTING PROCEDURE

- 9.1. All players must report to the Chief referee at the tournament desk **at least 30 minutes before** the scheduled match.
- 9.2. **15 minutes before**; 5 minutes warm up per player
- 9.3. **5 minutes before**; Conduct of lag to determine break
- 9.4. From 2nd session onwards, warm up is subjected to the time allowance after the end of previous match and also reporting time of player.
- 9.5. Matches on weekdays will be scheduled up to 2 sessions per day starting from 7:30pm.
- 9.6. Matches on weekends will be scheduled up to 4 sessions per day starting from 10:00am.

10. MATCH PROCEDURES

- 10.1. If a player is not present by the commencement time of the match;
 - Penalty of 1 rack
 - Not present by 5th minutes, penalty of 2 racks
 - Not present by 10th minutes, officially recorded as a walkover.
- 10.2. **A player shall concede a walkover, if they are not present at the table within 10 minutes of the scheduled commencement time. No grace period shall be granted.**
- 10.3. Each player will only be allowed to call 1 time-out (7 minutes) during the match. Players who exceed the time limit, a penalty of 1 rack will be conceded to his/her opponent.



11. SLOW PLAY AND 45 SECONDS RULE

- 11.1. Warning will be given if the overseeing referee deems there is a deliberate slow play.
- 11.2. The overseeing referee at his/her discretion may invent a shot clock of 45 seconds if he/she deems the match is proceeding too slowly.
- 11.3. A shot clock of 45 seconds will be used in 1 - 1 referee matches. When the shot clock reaches 35 seconds, the referee will call "10 seconds" to warn the player.

Failure to execute a shot within 45 seconds, will result in a foul shot giving the opponent a ball in hand.

12. OTHER CONDITIONS

- 12.1. Players are not allowed to smoke in the tournament venue.
- 12.2. Players are not allowed to place any cigarettes or lighters in the seating area.
- 12.3. Players are strictly prohibited from using their mobile phones during their match and must ensure that their devices are switched to silent mode.
- 12.4. Any form of conducting or participating in games of money or gambling is strictly prohibited during the tournament.

- 13.1. All enquiries or disputes will be referred to the chief referee during the tournament and his decision will be final.
- 13.2. All disciplinary matters shall be referred to Cuesports Singapore, whose decision shall be final on all matters arising.
- 13.3. The organiser reserves the right to amend the above set of rules and regulations with prior notification to all participants when it deems necessary. Any matter not covered by the above set of rules and regulations shall be decided by the organiser whose decision shall be final.
- 13.4. Failure to comply with these rules and regulations, even in the absence of a specifically stated penalty, may result in disciplinary action. Such actions will be determined at organizer's sole discretion, and its decisions on these matters shall be final and conclusive.
